KEY INFORMATION

Agreements are usually reciprocal.

Should it be an unilateral agreement, it is noticed with a *, meaning that LaScam represents the foreign collective management organization (CMO) in France or with ** when the foreign CMO represents LaScam in its respective territories of operation.

LaScam represents foreign CMO in Belgium only when it is requested. This is mentioned in the 1st column of the table: « (+ B) ».

Rights subject to **mandatory collective management** (definition differs depending on the country): they are subject to a nearly generalized collective management but the royalty paid to LaScam may be uneven.

Primary rights: Abroad, all broadcasters, whether public or private, have not necessarily concluded licenses yet with local CMOs. Only the exploitations of a broadcaster who has signed with the competent CMO allow the royalty collection via the agreements signed by LaScam. **Broadcasting** (linear) refers to live television. **Catch up** (non-linear) refers to re-broadcasted content.

On demand (non-linear) refers to content directly exploited online.

Distinctions between rights: some societies, such as VEVAM and LIRA in the Netherlands, collect different rights indistinctly. The payments are therefore made without any possible distinction (e.g. broadcasting rights and retransmission rights).

Videographic reproduction rights are not further detailed here since they are subject to collective management only when the publisher is in France and depend on the author's contract. Nevertheless, royalty collection in collective management is possible in Poland for the publication of a work co-produced with a producer established in Poland or in certain cases in Spain.

For **any type of use of the works authorized by the producer** out of the scope of the collective right management, it is the producer's responsibility to pay the royalties to the author based on operating revenues, in accordance with the intellectual property code while applying the clause that shall be included in this regard in the audiovisual production contract.
